Year In Review

2007: THE YEAR IN REVIEW

The Southwest Florida Region experienced strong economic growth in the areas of sales and employment over the past two years.

LABOR FORCE, EMPLOYMENT AND UNEMPLOYMENT The Southwest Florida labor force grew by 6,319 persons or 0.9% in 2007. Unemployment in the region increase to 4.7% in 2007 compared to 3.2% in 2006. In 2006, the coastal counties experienced low unemployment rates, while the rural counties (Glades and Hendry) had high rates of unemployment that exceeded the state level; following the trend of preceding years. As a whole, however, the regional unemployment rate was higher than the state figure for the year.

AIRPORT PASSENGERS The number of regional airline passengers increased this past year. Southwest Florida International Airport experienced a 5.3% increase in the number of Airline passengers; Sarasota/Bradenton Airport reported an increase of 9.2%, while Naples Airport reported a decrease of 35.6%. As in the past years, passenger traffic peaked in the month of March, with more than 1,290,782 people traveling through Southwest Florida Airports.

BUILDING PERMITS The construction industry, a major sector of the Southwest Florida economy, recorded an annual decrease in the number of building permits issued last year; due to the recent slump in the housing market. The region experienced a 68.9% decrease in the number of single family permits issued and a 59.2% decrease in the number of multi-family permits issued in 2007. Overall, total regional dwelling unit permits decreased by 68.1%. Please note in supporting tables: communities with incomplete information.

The value of all reported residential permits decreased 59.1% from \$6.9 billion in 2006 to \$2.8 billion in 2007. The total value of all reported permit activity decreased 42.8% from \$11.2 billion in 2006 to \$6.4 billion in 2007.

SALES ACTIVITY Regional gross and taxable sales decreased in 2007. Gross sales decreased 3.1%, from \$52.2 billion in 2006 to \$50.6 billion in 2007. Taxable sales totaled \$27.9 billion in 2007; a decrease of 7.6% over 2006 taxable sales of \$30.2 billion. Typically, the winter and spring months of December through May register the highest gross/taxable sales. January and April were the peak months for gross (\$5.6 billion) and taxable (\$2.9 billion) sales respectively.

CONSUMER PRICE INDEX The Consumer Price Index measures the cost of items in several specific categories and is used as an indicator of the general rate of inflation through time. Between 2006 and 2007, the Consumer Price Index for all Urban Consumers, of the CPI-U, rose 2.9% from 201.6 to 207.3.

Airport Activity

Airport passenger activity for the Southwest Florida Region increased 11.6% in January 2008 from December 2007. Airport passengers visiting and leaving the region totaled 937,610 as compared to 840,306 in the previous month. All four airports reported an increase in passenger activity from the previous month.

In January 2008, total airport activity for the region increased 1.6% from the previous year. Sarasota/Bradenton airport was the only one that reported an increase in passenger activity from the previous year.

Unemployment

The regional unemployment rate for January 2008 was 5.9%, which was higher than the revised rate of 5.6% for December 2007. Hendry County, at 7.2%, had the highest unemployment rate in the six-county region, with Charlotte County second at 6.8%. Glades County had the lowest unemployment rate at 4.8%.

The January 2008 regional unemployment rate of 5.9% was higher than the state at 4.7%. The regional unemployment rate increased by 72.8% from January 2007 to January 2008, while the state rate increased by 37.5%.

The Consumer Price Index (CPI-U) for all urban consumers measures the cost of items in several specific categories and is used as an indicator of the general rate of inflation through time. The CPI-U during January 2008 increased 0.5% from December 2007. The CPI-U for January 2008 was 211.1, an increase of 4.3% from January 2007.

Sales Activity

Sales activity in Southwest Florida is measured by gross and taxable sales for each county. For December 2007, gross and taxable sales in the region totaled approximately \$4.2 million and \$2.2 million, respectively. This is a 15.0% increase in gross sales and a 11.2% increase in taxable sales from November 2007. All counties reported an increase in gross sales and Hendry County was the only one to report a decrease in taxable sales this month as compared to November 2007.

Gross sales in the region between December 2006 and December 2007 decreased 4.2%. Taxable sales decreased 15.8% during the same period. By incorporating the change in the cost of living (4.30%) and the average annual population growth rate (4.3%) for the same time period, real gross sales decreased 13.3% per capita. Real taxable sales decreased 29.0%.

Building Permits

Residential building activity is measured by the number of single-family and multifamily building permits issued during a given month. In January 2008, 301 residential permits were issued in Southwest Florida. This is 666 less permits than were issued in January 2007. The number of units covered by these permits decreased by 722 from 1,307 in January 2007 to 585 in January 2008. Compared with the figures reported for December 2007, the number of units for January 2008 increased by 210. From December 2007 to January 2008, permits issued increased by 34.

The region reported a residential building valuation of \$109,156,911 in January 2008. This is a decrease of 62.6% compared to the valuation of residential permits issued in January 2007, which totaled \$291,510,258.

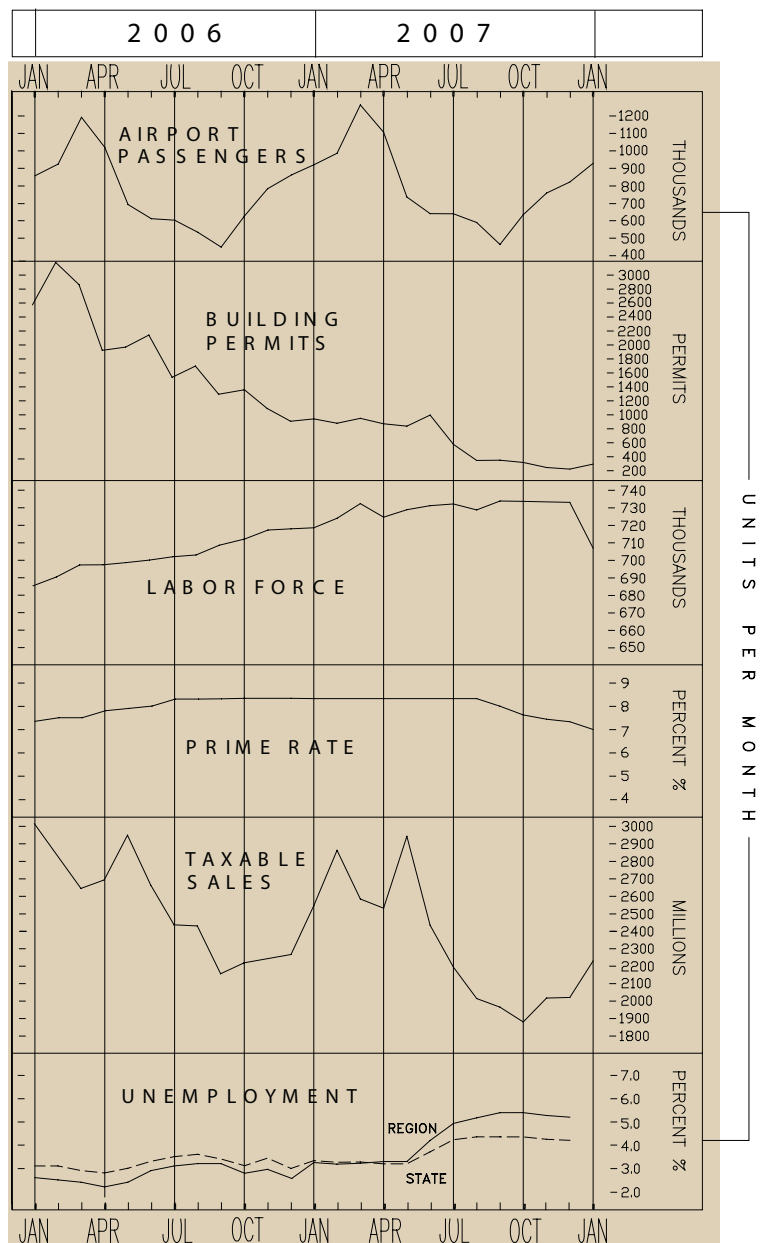

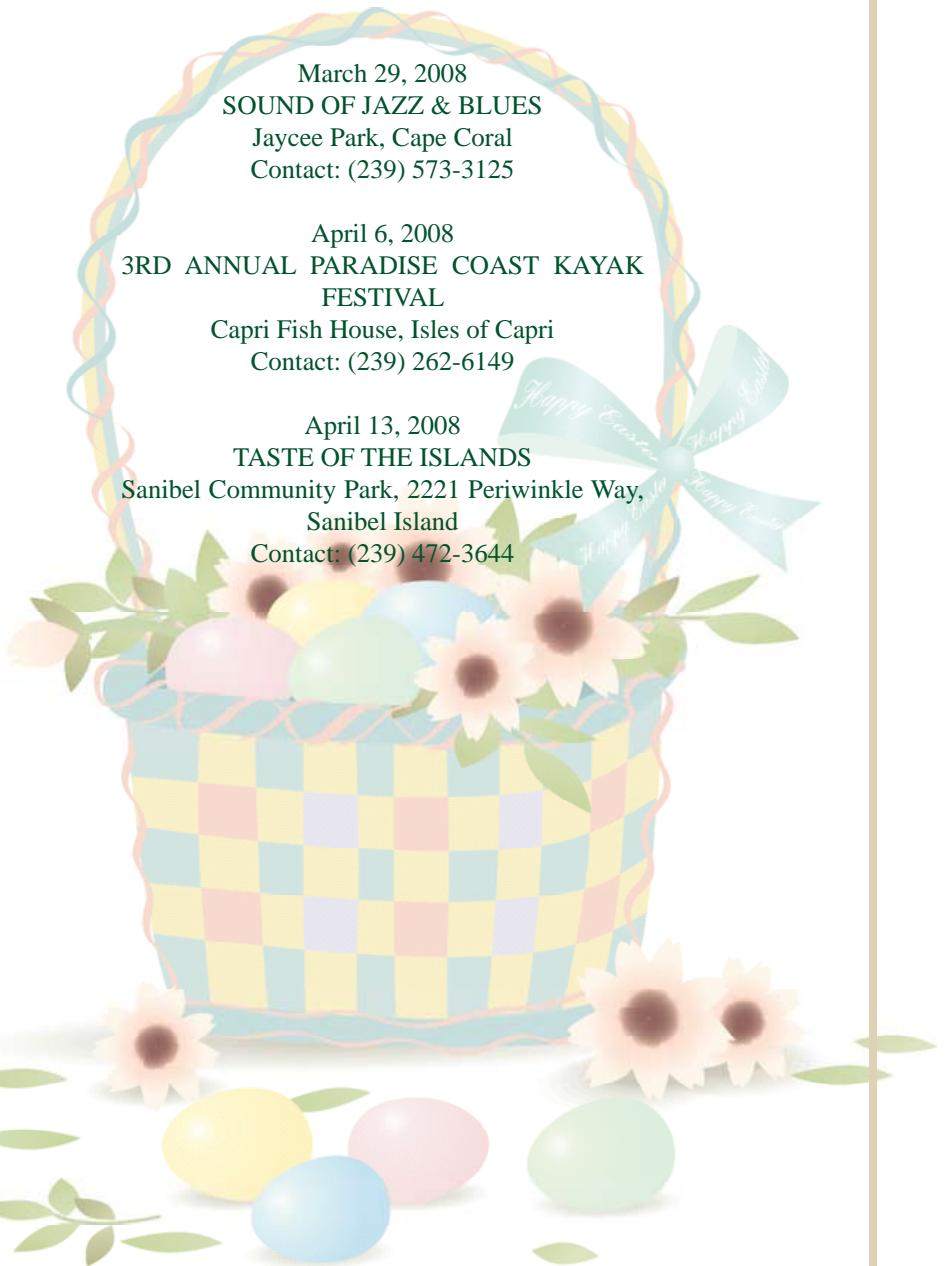
