<u>Item #1 – Welcome & Introductions</u>

The meeting was called to order by Mr. McCormick at 11:45 a.m. He then introduced both Mr. Flood and Ms. Harp.

Item #2 - Approval of Minutes: February 20, 2014

Mr. McCormick asked for approval of the February 20th meeting minutes.

A motion was made by Mr. Flood to approve the meeting minutes of February 20, 2014. The motion was seconded by Mr. McCormick and carried unanimously.

Item #3 – SM3 Request: Jurisdiction Scoring Summary Questionnaire

Mr. McCormick asked Ms. Harp to discuss the jurisdiction scoring summary questionnaire item.

Ms. Harp explained that the SWFRPC is disseminating this questionnaire to all local jurisdictions. Ms. Harp explained that data is currently collected for Charlotte County and the City of North Port.

Mr. McCormick asked how the document could be accessed.

Ms. Harp explained that it was available on the solarreadyflorida.com website, as well as linked to the agenda. Ms. Harp said she could also send out a separate email with this information.

Mr. Flood asked if this questionnaire was to rank local governments and their status. Ms. Harp confirmed the reasoning for the data collection.
